

The interested entities may register in the Unified Register of Economic Operators of the Holy See and the Vatican City State through the **ORDINARY procedure**.

**Only** the Entities listed in the following schedule may register in the aforementioned Register through a procedure identified in Sap Ariba as simplified.

Entities	Description
<b>Company with registered office in Italy falling within one of the following types:</b>	
Case 1.a	Company with shares listed on Italian regulated markets, subject to CONSOB supervision.
Case 1.b	Legal audit firm registered in the Register of Legal Audit Firms at the Ministry of Economy and Finance of the Italian State.
<b>Public law entities of the European Union:</b>	
Case 2.a	State Administration.
Case 2.b	Public schools and institutes of all levels/public educational institutions/public university institutions.
Case 2.c	Regions/Provinces/Municipalities/Mountain communities and their consortia and associations/Chambers of commerce, industry, crafts and agriculture and their associations or different territorial divisions.
Case 2.d	Company whose management is placed under direct supervision (majority participation/control), as evidenced by publication in special official lists, or indirect supervision of the State.
<b>Company with registered office in other States falling within one of the following types:</b>	
Case 3	Company with registered office in other European Union Member States, listed on regulated markets recognized by European law and subject to controls similar to those provided by Italian authorities in their respective sectors of competence.
Case 4	Company with registered office in Third States <sup>1</sup> , listed on regulated markets pursuant to legislation in force in the State of establishment <sup>2</sup> and subject to controls similar to those provided by Italian authorities in their respective sectors of competence.
<b>Company with registered office in Italy/European Union Member States/Third States<sup>1</sup> exercising its activity outside Vatican City State and falling within one of the following types:</b>	
Case 5.a	Company issuing financial instruments widely distributed among the public to a significant extent as identified by CONSOB and subject to its supervision; or company identified and supervised by bodies similar to those provided by Italian authorities in their respective sectors of competence.
Case 5.b	Company authorized by the Bank of Italy, as well as by bodies similar to those provided by Italian authorities in their respective sectors of competence, to exercise banking activity and registered in the appropriate Register.
Case 5.c	Financial advisory company established as a joint-stock company or limited liability company registered in the appropriate section of the Unified Register of financial advisors or in foreign registers similar to those provided by Italian authorities in their respective sectors of competence.
Case 5.d	Company qualified to exercise insurance or insurance intermediation activity, registered in the Register of insurance companies or in the Unified Register of Intermediaries at IVASS, or in foreign registers similar to those provided by Italian authorities in their respective sectors of competence.
<b>Other Entities:</b>	
Case 6	Public Juridical Persons of the Church (Ecclesiastical Entity)
